DESCRIPTION
LOT 3.12 BLOCK 27
THE SANCTUARY

UNION TOWNSHIP, HUNTERDON COUNTY, NEW JERSEY

BEGINNING at a corner common to Lot 3.11 and Lot 3.12, Block 27, on the Westerly Right of Way line of Asher Smith Road (40' R.O.W.), distant 440.33 feet as measured along said line on various courses from the intersection of same extended with the extended Northerly Right of Way line of Stirling Place; thence along a line common to said lots on the following two (2) courses:

1. North 74 degrees 05 minutes 16 seconds West, 201.51 feet; thence
2. North 56 degrees 17 minutes 03 seconds West, 742.46 feet; thence
3. Along a line common to Lots 1 and 3.12, North 56 degrees 21 minutes 03 seconds East, 199.62 feet; thence along a line common to Lots 1.01 and 3.12 on the following two (2) courses:
4. South 86 degrees 36 minutes 57 seconds East, 591.24 feet; thence
5. North 31 degrees 12 minutes 03 seconds East, 423.94 feet; thence along a line common to Lots 3.12 and 3.13 on the following two (2) courses:
6. South 04 degrees 53 minutes 59 seconds West, 688.30 feet; thence
7. South 20 degrees 08 minutes 12 seconds West, 75.51 feet to the aforementioned Westerly Right of Way line on Asher Smith Road; thence along said right of way line on the following three (3) courses:
8. Along the arc of a curve to the left having a radius of 58.00 feet, an arc length of 144.66 feet and a central angle of 142 degrees 54 minutes 23 seconds to a point of reverse curvature; thence
9. Along the arc of a curve to the right having a radius of 25.00 feet, an arc length of 23.31 feet and a central angle of 53 degrees 25 minutes 15 seconds to a point of reverse curvature; thence
10. Along the arc of a curve to the left having a radius of 520.00 feet, an arc length of 43.01 feet and a central angle of 04 degrees 44 minutes 21 seconds to the point of BEGINNING.
